PAYMENT OF ANNUAL DUES AND REGISTRATION/RENEWAL OF OUR STATES, DIVISIONS/DISTRICTS/ GROUPS/ TROOPS/PACKS/CREW/WINGS/SHIPS REGISTRATION AND OPERATING WARRANTS WITHIN THE NSO.

Greetings and my warm brotherhood complements!

The National Headquarters has noted with dismay our lack of interest across the NSO to fulfill our obligations as members of The Scout Association of Nigeria by not paying our annual dues as at when due. It is only when it is election time, or when we urgently need the NSO assistance or support for one thing or the other that we are compelled to comply and rush to pay. No association can survive or flourish when the composite structures and individual members refuse to pay their annual dues as at when due. When you do not pay your dues, you are not legally a bona fide member of the association, and technically your membership status is in abeyance, and not entitled to all rights and privileges of Scouting.

We are now in the third quarter of the year and the following were the current dues as per the category applicable to individuals or groups, viz.

1. Board Members =N=50,000 (minimum) per annum
2. State Councils =N=50,000 per annum
3. NEC Members (Including the SSCs) =N=24,000 per annum
4. SEC Members =N=12,000 per annum
5. LA Members & Other volunteers =N=12,000 (minimum) per annum
6. DIV/DCs =N=5,000. Per annum
7. Groups/Troops Registration =N=5,000 per annum
8. Application/Issue of Warrants =N=5,000 per annum
9. National ID Card Registration (All Scouts & Volunteers) =N=2,000 for initial ATM-ID Card (which covers the Digital ID Card, Linked Wallet Account, Name Tag and Insurance Cover (80%); and the Scout dues to National, State Councils, as well as, the Groups/Districts (20%))

For the records, all State Councils, individuals and groups/crew/wings/ships that have paid their 2024 annual dues up to date should forward the evidence of payment/transfer to the NHQ office or the National Treasurer.

It is our moral, legal and scout obligation to pay our annual dues as at when due to be entitled to the full rights and privileges of the Association as a Corporate member without hindrance.

All State Councils are also advised to send to the NHQ their Annual Census Figures on or before the 31st of August 2024 to meet up with their Annual Reports to present during the AGM.
